# **Terms of Service Agreement**

## 1. ACCEPTANCE OF TERMS

Welcome to HRCentry.com. HRCentry.com & Entry System Management Co LLC (ESMC) provides its service to you, subject to the following Terms of Service ("TOS"), which may be updated by us from time to time. ## 2. DESCRIPTION OF SERVICE

Whenever applicable within these Terms and Conditions, the singular shall include the plural and the plural shall include the singular.

## 25. Headings

The headings of paragraphs herein are included solely for convenience of reference and shall not control the meaning or interpretation of any of the provisions of these Terms and Conditions.

#### 26. No Waiver

No failure to exercise and no delay in exercising any right, power or remedy under these Terms and Conditions shall impair any right, power or remedy which ESMC may have, nor shall any such delay be construed to be a waiver of any such rights, powers or remedies or an acquiescence in any breach or default under these Terms and Conditions, nor shall any waiver of any breach or default by ESMC be deemed a waiver thereof.

# 27. GENERAL INFORMATION Entire Agreement.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the HRC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any HRC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our)participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons.
